**Financial Inclusion / PMJDY :  
Payment of Additional Commission to active BC-Agent (BCA)  
for providing Banking Services during COVID-19 pandemic  
for the month of July-2020 to Sept-2020**

In continuation to our earlier guidelines of captioned subject issued vide HO-Br-Cir. No.114/10 dated 30.03.2020, subsequently vide HO-Circular Letter Ref.No.2020-21/02A dated-18.04.2020. The matter was reviewed keeping in view the services provided by B.C. / Agent of Corporate BC during present phase wise of unlock-down situation during this difficult times.

2. Now, Competent Authority has approved continuation of payment of additional commission to active BC-agents as subsistence / financial support during COVID-19 pandemic lockdown for the month of July-2020 to Sept 2020, as per details enumerated herein below:

**Additional BC-commission:**

a) Payment of additional BC commission per day per BC-agent, subject to performing minimum of 10 online BC-banking-transactions per day on BC's Terminal/POS/FI-Kiosk with effect from 01.07.2020 to 30.09.2020, as under:

<u>Months:</u>	<u>Addl. BC Commission payable Per Day</u>
July 2020	Rs.75/-
Aug-2020	Rs.50/-
Sep-2020	Rs.25/-

- b) GST / Taxes /TDS extra as applicable.  
c) "Modalities of payment herein-case" as per extant bank norms & guidelines.  
d) All other terms and conditions with regard to Bank guidelines adopted on payment of BC-commission under Financial Inclusion / PMJDY and monitoring thereon remain unchanged, and details as per para 4 of B.C No. 114/10 dated 30-03-2020

**Payment Modalities:**

- Payments through Corporate-BC:  
Bank(HO) to ensure direct payment to the credit of bank account of Corporate BCs for the total eligible amount of additional BC-commission payable to their attached BC-agents, subject to :  
  
EACH CORPORATE-BC SHALL ENSURE SUBMISSION OF A CERTIFICATE TO BANK (HO-FID) DECLARING PAYMENT OF THE ELIGIBLE ADDITIONAL BC-COMMISSION IN FULL TO EVERY AND ALL ELIGIBLE BC-AGENTS.
- For eligible Individual BC-agents engaged by Zones:  
Zonal Office to ensure timely payment of eligible additional BC-commission, as per existing procedure hitherto.
